1. ELIGIBILITY - Entry is open to all current adult members of the SOUTHERN JERSEY SHORE USBC.
a. Non association USBC members may enter this tournament by paying the local association membership fee of $\$ 10$.
2. AVERAGES - It is the bowler's responsibility to verify the accuracy of their average. Average used is the HIGHEST Book Average for at least 21 games from the 2022-23 bowling season (as specified on bowl.com). If your current (2023-24) league average for at least $\mathbf{2 1}$ games is $\mathbf{1 0}$ pins higher than your highest 2022-23 Book Average, that average will be used. If the entrant doesn't have an average from the 2022-23 season, the entrant shall use their HIGHEST average from the current season for at least 21 games in a USBC certified league as of the tournament deadline (it will then be the responsibility of the entrant to submit a league standing sheet or appropriate documentation for verification). Bowlers NOT meeting any of the average criterion will not receive handicap and therefore must bowl SCRATCH (230). One of the bowlers must have an average of 200-above and the other bowler must have an average of 199below.
3. SUBSTITUTES - a substitute whose name and average is not shown on this entry form and can meet requirements shall use averages in the same order as shown in Rule 2.
a. It is the bowler's responsibility to notify the Tournament Director prior to check in of any changes to the legal lineup.

HANDICAP - The Handicap shall be on an individual bowler basis and shall be $80 \%$ of 230 .
BOWLER'S RESPONSIBILITY - the individuals whose names appear on this entry form shall be responsible for the accuracy of all info submitted including the order in which his team is to bowl.
a. Any information submitted incorrectly will result in disqualification of the entry and forfeiture of all prizes, bowling and expense fees.
b. All teams or individuals must bowl on the lanes assigned to them or forfeit their entry fee.
6. ENTRY FEES - $\$ 80 /$ team. Fee Breakdown: Lineage: $\$ 20 /$ Team, Prize Fund: $\$ 60 /$ Team
a. Entry fees must accompany this application.

FORMAT - This tournament will be a Doubles Tournament. Bowlers will bowl 3 games on the same pair of lanes.
This tournament will observe a one lane courtesy.
NO UNREASONABLE DELAY - USBC rule 11, the tournament officials shall allow no unreasonable play in the progress of any game.
a. Should any member or team participating in this tournament refuse to proceed in the game after being directed to do so by the proper authorities, such game or series shall be declared forfeited.
b. Once the tournament starts, the missing bowler will take a zero for each frame missed.
c. If there is no final sheet on file, bowlers must follow rule 2 above.
10. CHECK IN - Check in will be 1 pm , Practice 1:50pm, Tournament Play at 2 pm .
11. PRIZE MONEY - All prize fees collected in an event will be returned $100 \%$ to the participants in that event.
a. Prize checks will be mailed to the Team Captain.
12. Electronic Devices, phones, iPods, etc. will not be permitted unless for a medical condition. Scoring devices will be permitted.
13. INCLEMENT WEATHER and CANCELLATIONS - Tournament is subject to good weather conditions. During inclement weather, contact the center for further information. Should we need to postpone, the tournament will be held on alternate date at the discretion of the center. If the tournament is cancelled, the Tournament Committee will notify the bowler.
14. USBC rules will cover anything not specified here.
