SJS DOUBLES TOURNAMENT RULES and REGULATIONS
PLEASE READ CAREFULLY

1. Entry is open to all current adult members of the SOUTHERN JERSEY SHORE USBC. Bowlers not a SOUTHERN JERSEY SHORE USBC member must pay a Local Association Fee of \$10 if a member of another Association.
2. Format: Qualifying Round: Five (5) games listed below, on the same pair of lanes. Total pinfall plus team handicap will determine Qualifying Round standing. Cut to the Top 3 teams for a Finals round.
 - a. **Game #1: Baker Doubles (Bowler #1: Frames 1,3,5,7,9 Bowler#2: Frames 2,4,6,8,10)**
 - b. **Game #2: Baker Doubles**
 - c. **Game #3 Baker Doubles**
 - d. **Game #4: Scotch Doubles (Alternating throws every shot throughout the game)**
 - e. **Game #5: Scotch Doubles**

Finals Round: Top 3 team will bowl one (1) Baker game, on the same pair of lanes, to determine Tournament standings.

3. Entry Fee is \$50 per person and must accompany this form. Checks or Money Orders must be made payable to: **Southern Jersey Shore USBC.**
4. No entry money will be returned after entries are closed.
5. Pre paid Entries close 11:59PM, November 15, 2024. WALK-INS are permitted for a CASH ONLY fee of \$60/person (\$120/team).
6. All bowlers must report on lanes prepared to bowl at least 30 minutes before the scheduled squad time. Check-in will begin at 10am. Walk-ins please arrive by 10am to allow time to verify averages. Practice will begin at 10:50am and Tournament Play at 11am.
7. Line-up must remain in the same order as listed on this entry form.
8. Prize money paid into each event will be returned 100% to the winners in that event.
9. Prize checks will be mailed to the winners in accordance with USBC rules.
10. **AVERAGES – It is the bowler’s responsibility to verify the accuracy of their average. Average used is the HIGHEST book average for at least 21 games from the 2023-24 bowling season (as found on bowl.com). If your current (2024-25) league average for at least 21 games is 10 pins higher than your 2023-24 HIGHEST book average, that average will be used. If the entrant doesn’t have an average from the 2023-24 season, the entrant shall use their HIGHEST average from the current season for at least 21 games in a USBC certified league as of the tournament deadline (it will then be the responsibility of the entrant to submit a league standing sheet or appropriate documentation for verification). Bowlers NOT meeting any of the average criterion will not receive handicap and therefore must bowl SCRATCH (230).**
11. Handicap is 80% of 230 for individual calculations. Team’s handicap will be determined by adding both members handicap together and dividing in half.
12. Bowlers will observe a ONE LANE COURTESY
13. In case of a tie for the Championship Team, there will be a 9th and 10th frame rolloff to determine the winner.
14. Protests and scoring errors must be confirmed in writing within 24 hours. All decisions of the Tournament Committee are final unless an appeal is made in accordance with rule 329.
15. Bowlers arriving late will start to bowl in the same frame the team is bowling. Zero score for frames not bowled.
16. Tournament is subject to good weather conditions. During inclement weather, contact the center for further information. Should we need to postpone, the tournament will be held on alternate date at the discretion of the center.
17. Electronic devices, phones, iPods are not permitted unless used for a medical condition. Scoring devices will be permitted.
