Senior Tournament Rules and Regulations

1. Open to all USBC members 45 years old and older at the time of the tournament. Entrant must show USBC card. If not a member of Southern Jersey Shore USBC, a \$10 local membership fee must be paid.
2. This is a Singles event. Bowlers will bowl 3 games on the same pair of lanes.
3. The Handicap for this tournament is 80% of 230.
4. Bowlers will observe a one lane courtesy.
5. Prize fund split into 2 age divisions: Division 1- Ages 45-60 and Division 2- Ages 61-up.
6. 1:5 pay ratio per division.
7. Check-in will begin at 11am. Pre-registration cost for bowling is \$50 if application and payment is received by April 11. After that date, the cost for bowling is a cash only entry fee of \$60. Credit Card Payments will be accepted at the tournament site. Application must be mailed back to tournament manager by the closing date to qualify for the pre-registration cost. Walk-in bowlers are welcome for a cash entry fee of \$60 and must arrive at least 1 hour prior to bowling start time to allow the tournament committee to confirm average and to enter information into the computer. Check-in will close at 11:45AM. Practice will begin at 11:50AM and tournament play at 12:00PM.
8. AVERAGES- It is the bowler's responsibility to verify the accuracy of their average. Average used is the HIGHEST book average for at least 21 games from the 2023-24 bowling season (as found on bowl.com). If your current league average is 10 pins higher than your 2023-24 HIGHEST book average, that average must be used. If the entrant doesn't have an average from the 2023-24 season, the entrant shall use their HIGHEST average for the current season (2024-25) for at least 21 games in a USBC certified league as of the tournament deadline (it will then be the responsibility of the entrant to submit a league standing sheet or appropriate documentation for verification). Bowlers NOT meeting any of the average criterion will not receive handicap and therefore must bowl SCRATCH.
9. No absentee or vacancy scores. Late bowlers shall begin play with the score to count from the frame being bowled. Zero (0) score for frames missed. (Rule 322a.)
10. Protest and scoring errors must be confirmed in writing within 72 hours of the infraction or prior to Tournament prizes being sent out, whichever comes first. All decisions of the Tournament Committee are final unless an appeal is made in accordance with rule 329.
11. In case of a 1st place tie, a 9th and 10th frame rolloff will determine the winner.
12. Tournament is subject to good weather conditions. During inclement weather, contact the center for further information. Should we need to postpone, the tournament will be held on alternate date at the discretion of the center.
13. Electronic devices, phones, iPods, etc. will not be permitted during the tournament unless for a medical condition. Scoring devices will be permitted.
